5. Fire-fighting measures

Recommended extinguishing media; alcohol resistant foam, CO². powder, water spray.

7. Handling and storage

Handling**In Storage**

Handle containers carefully to prevent damage and spillage.

In Use

8. Exposure controls and personal protection

Engineering Measures

Respiratory Protection

When concentrations exceed the exposure limits shown above workers must wear appropriate respirators approved in accordance with Directive 89/656/EEC and the Personal Protection Equipment Regulations.

Hand Protection

Gloves of an appropriate material should be worn during mixing and application.

Skin Protection

Overalls which cover the body, arms and legs should be worn. Skin should not be exposed. Barrier creams may help to protect areas which are difficult to cover such as the face and neck. 10. Stability and reactivity
